

## Thank you for supporting ICS

### Information for members

1. Members are bound by ICS's Memorandum and Articles as it is a company limited by guarantee, and any rules in force from time to time.
2. ICS's object is to 'advance the Christian gospel by evangelical mission and ministry to English-speaking people throughout the world.' (cl. 3, Memorandum).
3. ICS's Basis of Faith is in the Memorandum and is available from ICS and its web site.
4. No one shall be admitted to Membership without being first approved by the Council (cl. 3, Articles).
5. To become a Member a person must signify in writing that he/she is in full agreement with the object, wishes to promote the same by prayer and giving (cl. 4, Articles), make a membership declaration (cl. 8, Memorandum), and pay an annual subscription which is due on the date of acceptance of an application for Membership by the Council and annually thereafter. Amounts vary annually.
6. Subscriptions must be unrestricted gifts to the general fund of the Society. Subject to our usual conditions of acceptance members may express the wish that we use other amounts for projects.
7. Payments made by or on behalf of a Member (e.g. via or grouped with those of a third party) must be clearly identified.
8. Due to company law, Members cannot opt out of receiving certain documents from ICS and a register of Members must be available for public inspection.

### INFORMATION FOR DONORS

**UK taxpayers:** the value of your gift(s) to ICS can be increased at no extra cost to you by using Gift Aid. You can use Gift Aid if (during a tax year) you pay an amount of UK income or capital gains tax at least equal to the amount of tax we will reclaim on your gift. Please complete the declaration if you are eligible. If your tax position (such that you can no longer use the Gift Aid scheme), name or address changes please notify ICS immediately. We may periodically ask you to reconfirm your tax status. **US taxpayers** can make donations over \$500 to ICS (a non-profit organisation) through CAFAmerica or of any amount via DFMS as a tax-deductible gift. **Gifts** for specific objectives or projects: if donations exceed the sums required, we will allocate your gift to our general fund. Our full donation policy can be found on our web site.

**Data Protection:** data about individuals and organisations that ICS is in contact with may be held in its manual or electronic databases for the purposes of pursuing its activities. We may contact you by post, phone or e-mail unless you tell us that you do not wish to be contacted. ICS does not pass mailing lists to unconnected third parties.
